O R D E R

As per the Paddy procurement and delivery of CMR guidelines for KMS 2021-22 issued through memo No.3576-FNS/24012/4/2021 dated 9th October, 2021, Rice millers have to furnish security deposit in the form of Bank Guarantee, which has been prescribed as per the CMR delivery performance of Rice millers in the KMS 2021-22.

Whereas, it is the obligation of Rice mills to install blending machine for fortification of rice within 31st January, 2022 as per the agreement signed by the empanelled rice mills for milling of paddy purchased by the Food & Supplies Department, Government of West Bengal.

A. Now, in the interest of timely delivery of CMR and implementation of supply of fortified rice in the Public Distribution System, it is hereby ordered that Rice mills who will satisfy any of the following conditions will receive double the amount of paddy equivalent to the Bank guarantee notified in the Paddy procurement and delivery of CMR guidelines, KMS 2021-22:

A.1. Rice mills who have performed well in the last KMS and during the current KMS also on following points:

- (i) Regular, timely and complete delivery of CMR,
- (ii) Proper staking and identification of paddy and CMR stocks,
- (iii) Maintenance of records and registers,
- (iv) Non- failure of delivery of CMR after issuance of RRO.

After obtaining reports from the DCF&Ss, Director, DDPS will send the list after verification to the Department within 31/1/22.

A.2. Rice mills who have installed Blending machines for fortification of rice within 31st January, 2022, in terms of procurement policy order no. 3576-FNS dated 9th October, 2021 and agreement with the Rice Millers. Installation has to be inspected and certified by an Inspector with photograph.

B. It is also hereby ordered that rice mills who have not signed Bi-partite agreement with requisite Bank Guarantee till the 31st January, 2022 in this KMS and would like to participate in paddy procurement operations in KMS 2021-22, shall furnish the double Bank Guarantee than the Bank Guarantee as notified in the Paddy procurement and delivery of CMR guidelines, KMS 2021-22.
