**Sub: Revised Target of paddy procurement through CPCs and by CMR agencies
for KMS 2021-22.**

Sir,

With reference to above, I am directed to inform you that the Department has revised the target of paddy procurement from 49 LMT to 55 LMT for KMS 2021-22 for smooth running of PDS and also to meet the requirement of additional rice for PMGKAY-VI vide Finance Department U.O. No. Group A-II/2021-2022/0041 dated 30.09.2021.

In view of the above, the target of paddy procurement for CPC has been enhanced from 30 LMT to 34.20 LMT and that of CMR agencies from 19 LMT to 20.80 LMT. The detailed district wise revised target of paddy procurement and district wise revised monthly target of CPCs and CMR agencies have also been annexed.

This issues with the approval of the competent authoity.
