Sub: Checking of weigh bridge and weighing machines by the Legal Metrology officers in all the CPCs and the paddy purchase camps organized by the CMR agencies of the State -reg.

Sir,

In reference to above, I am directed to request you to instruct all DCF&S(s)/ District Managers/Officials to sensitize the Purchase Officers (POs)/Disbursing Officers (DOs) and other officials engaged at CPCs/Paddy Purchase Centres to assist the officers of Legal Metrology in getting certificate of all weighing devices (weigh bridges, electronic weighing machines) installed in different Centralized Purchase Centers (CPCs) including other functional paddy purchase centers opened by different CMR Agencies throughout the State by paying requisite fees through GRIPS portal. You are requested to instruct the concerned Officers/Officials to discard the use of manual weighing machine, if any, used in different CPCs/Paddy Purchase Centres.

I am further directed to request you to send an advisory to all DCF&Ss/ District Managers/Officials to instruct the Purchase Officers (POs)/Disbursing Officers (DOs) of all CPCs and other officials engaged in the paddy purchase camps organized by the CMR agencies regarding the purchase of paddy without following the uniform SOP, as notified in the Guidelines for Procurement of Paddy and Delivery of CMR published for KMS 2021-22 vide no. 3576-FNS/24012/4/2021 dated 09.10.2021 to check abrupt deduction due to high moisture, impurities etc. of paddy quantum.
