ORDER

In continuation of the comprehensive order no. 3576-FNS/24012/4/2021 dated Kolkata, the 9th Oct, 2021, for procurement of paddy and Custom Milled Rice (CMR) in connection with the procurement for KMS 2021-22, the Government has further decided to issue the following order:-

1. The Minimum Support Price (MSP) of paddy is Rs. 1,940/- per quintal for the KMS 2021-22.
2. It is also decided that incentive of Rs. 20/- per quintal over and above MSP of Rs. 1940/- per quintal would be given to the farmers who would sell their paddy at the Centralized Procurement Centres (CPC) including Direct Purchase Centres (DPC) and CPCs set up by CMR Agencies.
3. The maximum quantity of paddy that a farmer may sell is 45 quintal for the entire KMS 2021-22.
4. The procurement of paddy from the farmers and delivery of resultant Custom Milled Rice (CMR) for KMS 2021-22 will be done from 1st November, 2021 till 30th September, 2022.
